SPOTSYLVANIA COUNTY CRIME SOLVERS

From January 2008 through December 2018, the Spotsylvania County Crime Solvers has paid out \$49,750 in **CASH REWARDS** for information through 2,125 calls to the Crime Solvers Telephone Tip line, Crime Solvers Web Tip page, the former Text-A-Tip phone number, and the new P3 App Tip system. Information obtained has resulted in 193 arrests involving burglaries, drug distribution, arson, vandalism, breaking & entering and other crimes against the citizens of Spotsylvania County. To date there has been \$158,632 worth of stolen property recovered, and property and assorted types of drug seized. From June 2010 through December 2018, 63 Wanted Fugitives have been arrested and are facing or faced their charges.
