### Crime Solvers Statistics

From January 2000 through December 2019, the Spotsylvania County Crime Solvers has paid out over **\$100,000** in **CASH REWARDS** for information through **2,320** calls to the Crime Solvers Telephone Tip line, Crime Solvers Web Tip page, the former Text-A-Tip phone number, and the new P3 App Tip system. Information obtained has resulted in **207 arrests** involving burglaries, drug distribution, arson, vandalism, breaking & entering and other crimes against the citizens of Spotsylvania County. To date there has been **\$164,132** worth of stolen property recovered, and property and assorted types of drugs seized. From June 2010 through December 2019 **64** Wanted Fugitives have been arrested.
