# **Crime Solvers Statistics**

From January 2000 through December 2019, the Spotsylvania County Crime Solvers has paid out over <u>\$100,000</u> in CASH **REWARDS** for information through <u>2,320</u> calls to the Crime Solvers Telephone Tip line, Crime Solvers Web Tip page, the former Text-A-Tip phone number, and the new P3 App Tip system. Information obtained has resulted in <u>207 arrests</u> involving burglaries, drug distribution, arson, vandalism, breaking & entering and other crimes against the citizens of Spotsylvania County. To date there has been <u>\$164,132</u> worth of stolen property recovered, and property and assorted types of drugs seized. From June 2010 through December 2019 <u>64 Wanted Fugitives</u> have been arrested.
