### **Crime Solvers Statistics**

From January 2000 through December 2019, the Spotsylvania County Crime Solvers has paid out over \$100,000 in CASH REWARDS for information through 2,320 calls to the Crime Solvers Telephone Tip line, Crime Solvers Web Tip page, the former Text-A-Tip phone number, and the new P3 App Tip system. Information obtained has resulted in 207 arrests involving burglaries, drug distribution, arson, vandalism, breaking & entering and other crimes against the citizens of Spotsylvania County. To date there has been \$164,132 worth of stolen property recovered, and property and assorted types of drugs seized. From June 2010 through December 2019 64 Wanted Fugitives have been arrested.
